The amount is based on an overall approved monthly budget for program grants to recipients. The Qualified Recipient Committee is composed of nurses, educators, professionals, and breast cancer survivors. Direct bill payment means that money is sent to the successful applicant's creditors; no money is sent directly to the successful applicant.

The amended return shows this answer as "no".

Form 990, Part VI, line 1a "(explain any) material differences in voting rights among members of the governing body"

This had not been explained in the original filing. The Board is composed of Officers and Directors. Only Directors have a vote. Those Board members who are both an Officer and a Director have a vote by virtue of being a Director.

Form 990, Part XII, line 2a "Were the organization's financial statements compiled or reviewed by an independent accountant?"

This question was mistakenly left un-answered. The financial statements were not compiled or reviewed by an independent accountant but were audited by an in independent accountant.

Schedule J (Form 990), Part II, lines 1 (i) and 2 (i) "Officers, Directors, Key Employees and Highest Compensated Employees"

For the two persons listed, line (i) was not filled out. The amended return lists all these values as "0".

Schedule G (Form 990), Part IV "Supplemental Information"

The explanation "Their soliciting and event-planning activities were entirely limited to Michigan" was added to the amended return.
